# **GETTING CHILDREN READY FOR SCHOOL**

All children are ready to benefit from a quality kindergarten experience when they are five years old by September 1 of that school year. But kindergarten readiness—the critical stage at which children are prepared for learning and success—is more than a matter of age. For a strong start in school, children need positive relationships and supportive learning environments beginning at birth. At First Steps, we partner with families, caregivers, and communities to ensure that all children are prepared for success.

# **PIVOTING FOR COVID-19**

When the coronavirus pandemic forced South Carolina to shut down in March 2020, Richland First Steps quickly pivoted to provide much-needed support to young children, their families and childcare providers.

Our work has never been more critical. While children are at low risk for the serious health effects of the virus, the crisis is having a profound impact on their wellbeing and development. For children of color and low-income communities, these impacts are expected to be even more damaging. That is why Richland First Steps is enhancing our efforts to provide parents and caregivers with the services and resources they need to weather this storm.

"Whether enrolled in classrooms, family child care, or home-based services, Head Start and Early Head Start children stayed home and programs did their best to continue to provide meaningful services remotely. However, suspending in-person services did not mean programs were closed.

Head Start and Early Head Start programs provided critical support for children and families. They delivered food, educational supplies, and materials, and provided remote teaching and learning experiences. Programs continued to be a lifeline for some of the nation's most vulnerable families. No one can call that closed."



In coordination with First Steps local partnerships and more than 230 private, community and faith-based preschool providers, First Steps 4K expands access to quality early education across the state.

#### **PIVOTING FOR COVID-19**

When schools closed due to COVID-19, First Steps 4K classroom converted to distance-learning, with teachers creatively supporting their young learners through video chat, take-home materials, and hands-on projects that caregivers could facilitate at home.

Our Early Head Start program, funded by the US Department of Health and Human Services (US DHHS), was funded in December 2009 with money through the American Recovery and Reinvestment Act (ARRA) of 2009. This grant allowed for service to 96 families in the primary zip codes of 29203 and 29204. Over time, the zip code area has expanded to all zip codes in Richland County, north of Blossom Street. These families are served in two different program options - center-based and home-based. Classrooms are located on the campuses of Ridgewood Missionary Baptist Church and Reformation Lutheran Church, and we're about to open our newest center at Virginia Wingard UMC with our newest EHS grant. This program leverages \$1,513,044 in operations, training and match dollars to provide services to families.

Early Head Start produces a standalone annual report that is presented to US DHHS after the program year concludes each August. If you would like to view a copy of the 2019-
